









Guide for the Tender for the Allocation of Beds to University Students in CX's Residences



Introduction



CX operates in the university student housing industry with the aim of facilitating students' academic career through the management of university residences. 1. Spaces and services

Various types of accommodation are available in the residences, including single and double rooms. In addition, there are communal spaces designed to encourage study and community life.

2. Allocation procedure

There are two different allocation procedures for Students who are already housed at a specific Residence (hereafter, 'Renewal Student') and Students applying for a specific Residence for the first time (hereafter, 'New Student').

A Renewal Student can only apply for the same Residence in which they are already housed. In the event that a student is already housed in a CX Residence but they wish to apply for a different CX Residence, they shall submit a new Application for the Allocation of a Bed for the facility of interest and will be considered as a New Student.

WHAT KIND OF STUDENT ARE YOU?

RENEWAL STUDENT

- 1. Fill in the application for the allocation of a bed and the online form

 By 31 May 2024
- 2. Wait for the email informing you that you have been allocated a bed and for the booking confirmation
- 3. Return the booking confirmation signed by you
 Within 2 days of receipt of the booking confirmation
- 9 4. Get ready to enjoy one more year with CX

NEW STUDENT

- 1. Get in touch with us through our channels
- 2. Check your email account and fill in the application form to request the allocation of a bed for the academic year 2024/2025 By 15 June 2024
- 3. Wait for the email informing you that you have been allocated a bed
- 4. Pay the requested amount as a security deposit and send send (i) the payment receipt, (ii) a scan of your ID card by email Within 3 days of receipt of the email informing you that you have been allocated a bed
- 5. Wait for the booking confirmation
- 6. Return the booking confirmation signed by you Within 2 days of receipt of the booking confirmation
- 7. Get ready to check in at CX











2.1 Requirements for allocation

According to the Tender, at the time of Application Students shall meet the following requirements:


WHAT KIND OF STUDENT ARE YOU?

RENEWAL STUDENT

Students shall meet the following requirements:

- having complied with the CX Rules and Regulations during their stay at a Residence;
- having no criminal record and no pending charges;
- being immune to diseases compatible with community life;
- not having been in breach of the 'General Rules and Regulations' in force at the Residences;
- being up to date with the payment of the amounts provided for by the contract at the time of submission of the application.

Failure to meet even one of the abovementioned requirements for Allocation shall result in the applicant being excluded from the selection process.





NEW STUDENT

Students shall meet the following requirements:

- being enrolled in a degree course in (i) legally recognised state and non-state universities, with the exception of distance learning universities, (ii) higher institutes of music and choreographic studies, or (iii) institutes of artistic and music training and specialisation;
- · having no criminal record and no pending charges;
- being immune to diseases compatible with community life.

Failure to meet even one of the abovementioned requirements for Allocation shall result in the applicant being excluded from the selection process.

INTERNATIONAL STUDENT

In addition to the requirements set out above, international students enrolled in the first year of a degree course shall:

• self-certify their knowledge of the Italian language.

2.2 Award notice and allocation acceptance

Each student will be notified by Campus X's Management by e-mail ("Assignment Email").

Students are required to confirm their acceptance of the bed (the "Acceptance") within 2 days, under penalty of forfeiture of the assignment, as of the date of receipt of the Assignment Email, according to the indications in the Assignment Email itself.

2.3 Late applications

Didn't make it in time to participate by the deadline set by the tender? You can still apply by following the procedure described in the tender notice published on our dedicated webpage.











3. Truthfulness of declarations

Declarants shall be responsible for the declarations made and the benefits obtained shall be forfeited if their declarations are found to be false. False declarations shall be punished under the Italian Criminal Code and specific laws on the matter (Articles 75 and 76 of the Decree of the President of the Italian Republic of 28 December 2000 No. 445). Moreover, Campus X - through any means whatsoever - may carry out spot checks on the declarations provided, and it reserves the right to ask for additional documentation, if needed.
