

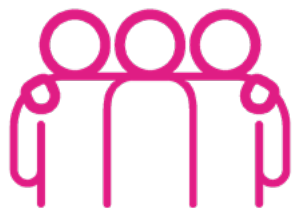

1. Spaces and services







Various types of accommodation are available in the residences, including single and double rooms. In addition, there are communal spaces designed to encourage study and community life.

2. Allocation procedure






To request the allocation of a bed, you must submit an application by following the instructions sent via email after expressing interest in the CX facilities. Applications must be submitted no later than **25 July 2025**, unless extended. If a candidate submits more than one application, only the most recent one will be considered.

After submitting the application, only for the CX Modena | Crocetta facility, you will be asked to indicate your ISEE bracket: you may be eligible for a discounted rate.

-  6. Sign the contractual documentation and get ready for check-in at CX

2.1 Requirements for allocation

According to the Tender, at the time of Application Students shall meet the following requirements:

Students shall meet the following requirements:

- enrollment in any institution of higher education (including but not limited to universities, higher institutes of musical and choreutic studies, institutions for artistic and musical training and specialization, etc.);
- having no criminal record and no pending charges;
- being immune to diseases compatible with community life.

Failure to meet even one of the abovementioned requirements for Allocation shall result in the applicant being excluded from the selection process.



2.2 Award notice and allocation acceptance

Each individual student will be informed via email by the Foundation or, on its behalf, the Manager, of the outcome of the bed allocation procedure. To complete the Bed Assignment procedure, the eligible student must submit the signed contractual documentation in its entirety by the deadline indicated by Campus X or the Experience Foundation, following the instructions provided.

2.3 Late applications

3. Truthfulness of declarations

Declarants shall be responsible for the declarations made and the benefits obtained shall be forfeited if their declarations are found to be false. False declarations shall be punished under the Italian Criminal Code and specific laws on the matter (Articles 75 and 76 of the Decree of the President of the Italian Republic of 28 December 2000 No. 445). Moreover, Campus X - through any means whatsoever - may carry out spot checks on the declarations provided, and it reserves the right to ask for additional documentation, if needed.
